

## Fortymile River Area Authorized Stream Locations

**ADVISORY:** Numerous waterbodies in the Fortymile River area lie within a Wild and Scenic River Corridor and are therefore wholly managed by the BLM; suction dredging is prohibited by the BLM unless you have an approved mine plan on an existing federal mining claim. Generally, for all streams listed as “Wholly Managed by BLM” you can assume that suction dredging is prohibited. Some of the streams listed as authorized may be partially managed by BLM and suction dredging is prohibited in those areas. You are advised to contact the BLM at (907) 474-2200 before going to the field for further information.
